#### 3. ELIGIBILITY CONDITIONS

**3.1 Eligibility Criteria**:- Bidder should be a professional with a minimum of 3 years experience in providing in house catering services to training institutions/Government Organizations /Public Sector Units/ Autonomous Bodies/ Banks/ Corporate Bodies/ Reputed other entities

The following are other minimum eligibility criteria for the caterer to participate in the tender "for providing Food service to KIED, Kalamassery".

- i.) Should be based in proximity of 20 to 25 Kms from KIED, Kalamassery and should be able to provide quality and hygienic cooked /prepared food and delicacies'
- ii.) Should have the registration of Food Services under the relevant statute/Act, either as a sole proprietor or a registered firm or a company to run food catering services. The bidder should not have rescinded or abandoned any contract awarded by any of his clients before the expiry of prescribed period of contract.
- iii.) Should be free from all encumbrances, liabilities, disputes and litigations with respect to its ownership and shall have all required approvals/permissions from the competent authorities to participate in the building process.

- iv.) Having Valid Food license under FSSAI (Food Safety & Standard Authority of India). It is mandatory for the bidder to have a Food License under Food Safety Act, 2006
- v.)The bidder can be an individual or a firm or a company having valid registration certificate under respective laws.
- vi.) Having Valid GST Registration Certificate
- vii.) Having Valid PAN
- viii.) Should have experience of serving to any educational institute / any Corporate / any PSU bodies for not less than 30 pax per meal during minimum three years (from 2018-19 to 2020-21) Copy of work orders/ Experience certificate should be submitted
- **3.2-Bid evaluation-**In the first stage of evaluation process, only Technical Bid (annexure-1) of the bid will be opened. The Technical Bids will be evaluated for credentials, experience, capability, past performance based on documents submitted in Technical Bid. Those bidders satisfying the Technical requirements as determine by the KIED with respect to Tender Conditions alone shall be short-listed
- **3.3 Other requirements:** A declaration to the effect that the Caterer has not been blacklisted by any of the organization at any point of time and no criminal/civil case is pending against the said caterer should be submitted along with the tender documents.

#### 4. GENERAL TENDER CONDITIONS:

- **4.1 Scope of work-**Subject to various conditions prescribed herein the scope of work includes
- i). Bidder shall have to prepare food as per menu at its premises.
- ii). Transport the prepared food to KIED dining hall and prepared food shall reach the KIED Campus 30 minutes before the time schedule shown in condition number 4.4 here below.
- iii). Serve the prepared food as per time schedule shown herein.

iv). Cleaning of utensils, plates, glasses, tumblers used for serving the food and has to clear the dining area at the end of each meal. Utensils and other accessories to transport and serve the prepared food shall be arranged by the bidder and will have to take back immediately after serving meals.

v). Entire waste materials shall be removed and disposed of from premises of KIED at bidders own cost and no extra payment in this regard shall be paid.

vi). Drinking water also to be supplied along with cooked food.

**4.2. Menu**: Day wise sample menu is mentioned in the Financial Bid document which is required to be changed once in a month in consultation with the Officers of KIED to bring in variety of food.

**4.3**. **Place of Supply:** Food serving locations: Dining hall of Hostel Block or KIED Campus. Caterer will have to make its own arrangement for ferrying cooked/prepared food to KIED premises for which no extra payment will be made except quoted rates.

**4.4 Food Serving Timings**: The selected Caterer will be responsible for providing food and beverages between the time periods prescribed here below

I. **Bed Coffee** : From 6.00am to 7.00am : From 7.30am to 9.30am Breakfast II. Tea break : From 11.00am to 11.30am III. IV. Lunch : From 1.00pm to 2.00pm ٧. Tea break : From 3.00am to 3.30am VI. Dinner : From 8.00pm to 9.00pm

Timings may vary based on the Class/ Training schedule which will be informed in advance.

a. The food should reach the venue at least 30 minutes before the above scheduled time. No Delay will be entertained under any circumstances, however, the request for delay may be considered in unavoidable circumstances with prior information or approval from the competent authority of KIED.

- b. The count of students for serving the food will be provided by KIED representative on daily basis.
- **4.5 Manpower Deployment:** The caterer is required to deploy minimum of 2 persons for serving the food and for cleaning (removing the plates, used tumblers, cleaning the tables, used crockery etc) at all timings when the food is served. The basic cleaning should be undertaken by the Caterer only.
- **4.6 Sanitation Items:** The caterer should provide the sanitation items like soap oil/hand wash liquids for washing the hands & tissue papers where the food is served. Replenishing of the items is the responsibility of the caterer only.
- **4.7 Cutlery/ Crockery for serving food:** The caterer should provide proper and required number of cutlery/crockery items like glasses, serving bowls, plates, spoons etc of good quality for serving the food. Replenishing of the items due to breakage/damage is the responsibility of the caterer only.
- **4.8 Grooming:** The caterer should ensure that the team follows the uniform with shoe polished, wear the head caps and hand gloves. The caterer should present themselves with groomed well and compulsorily wearing mask.
- **4.9 Dustbins with Garbage covers:** The Caterer should provide required dustbins and garbage covers at all the locations at food serving area and the disposal of garbage on daily basis is the responsibility of the caterer only.
- **4.10 Medical tests &Insurance:** persons who prepare/ serve food should maintain high degree of cleanliness and personal hygiene. They should be medically fit and suitable to cook and serve. They should be comprehensively insured by the Caterer for any accidents and injuries. No REIMBURSEMENT will be made.
- **4.11 Inspection of Kitchen:** The Caterer should allow KIED representatives to inspect / check the kitchen at periodical intervals.
- **4.12 Food Test Reports**: The Caterer should, at his own cost, get the food tested at the laboratory specified by us and furnish a report of suitability at least once in SIX months or as and when demanded by us.

#### 4.13 Statutory Requirements:

- i. The Caterer shall be solely responsible to comply with all Acts, Laws, Rules and Regulations, as may be applicable from time to time in respect of providing catering services and shall pay all taxes, debts and / or levies as may be levied by the appropriate Government / Local Bodies and other authorities in this regard, and the Carter shall indemnify the KIED, Kalamassery against all claims, loss damage and costs thereof in case of any breach of any of these Acts, Laws, Rules and Regulations.
- ii. The vendor/ Caterer shall not sublet, transfer or assign the contract or any part thereof without the prior written approval of the KIED, Kalamassery.
- iii. The vendor/ caterer shall comply with all the terms and conditions and ensure supply of the prescribed quantity of food items during the service timings and in the event of any failure or breach of any of the conditions by the Service Provider and in case of deterioration in the quality of the food items or reduction in the quantity thereof, KIED shall be at liberty to levy penalty of Rs. 5,000/- per instance or the total food cost of that meal, as deemed appropriate, in case of hygiene Issues like Worms/ Insects or any other harmful particles found in food served.
- iv. The bidder being service provider shall agree to hold harmless and indemnify the KIED from any and all liability arising out of negligence from the part of the service provider in connection with the performance of the services described in this tender notice.

#### 4.14 Security Deposit.

- Interested bidders are required to pay a refundable amount of Rs.5, 000/-(Rupees Five thousand only) towards EMD with Technical Bid.
- Successful bidder is required to pay a refundable amount of Rs. 10,000/-(Rupees Ten Thousand only) at the time of execution of agreement towards security deposit including EMD amount of Rs.5000.
- iii. Security Deposit of bidder will be forfeited if the bidder withdraws or amends contract conditions or impairs of derogated from the contract in any respect or

breach of tender and contract conditions within the period of validity of the contract.

## 4.15. Bill Payments.

- a. The Caterer is required to maintain all records with regard to the supply of food and should get it verified by KIED representative on regular basis.
- b. Payments shall be made after completing the training programmes through digital fund transfer to the bank account of the claimant within 30 working days on receiving the bills/invoices with all supporting documents from the caterer after deducting TDS and other statutory recoveries applicable at appropriate rates. That is all applicable taxes and charges will be deducted at source at the time of settlement of each bill.
- c. The caterer shall not be entitled to any increase on the quoted rates or any other rights or claim whatsoever by reason of any representation, explanation or statement or alleged representation, promise or guarantee given or alleged to have been given to him by any person. The rates quoted and accepted shall remain same and firm during the validity period of the contract and enhancement of any nature shall not be allowed under any circumstances.
- d. KIED, Kalamassery will not pay any advance or mobilization fund to the Food catering contractor.

#### 4.16. Contract Period.

- a. The contract will be for a period of 6 months initially from the date of execution of agreement and may be extended with same terms and conditions for one more year based upon the satisfactory feedback from all the stakeholders of the KIED, Kalamassery.
- b. During the contract period, KIED, Kalamassery will not entertain any request for revision of rates.
- **4.17-Legal Compliance** The contractor shall comply with the relevant regulations relating to preparation, supply and serving of food stuffs, beverages and refreshment and shall obtain all the necessary sanctions and licenses and permits at its own cost

- **4.18**. **Terms of Termination of Contract:** The food catering contract can be terminated by either side by giving a notice of not less than 30 days in advance without showing any reason for the termination of the contract. If the contractor commits breach of any of the conditions stipulated in this contract and fails to render the services to the satisfaction of the KIED, the contract shall be terminated without notice and Security Deposit furnished will be forfeited by the KIED.
- **4.19. Arbitration**: In case of any dispute arising out of the terms and conditions of contract or assignment, the matter shall be referred to the Sole Arbitrator to be appointed by the CEO & Executive Director, KIED, Kalamassery as per the relevant Act and the award of the Sole Arbitrator will be binding on both the parties. The cost of such arbitration shall be shared by both the parties equally.

Further, any legal dispute arising shall be settled in the court of competent jurisdiction located within the local limits of Ernakulam.

#### 4.20. Other General Conditions.

- 1. No representation for enhancement of price once accepted will be considered during the currency of the contract.
- 2. Any attempt on the part of quotations or their agents to influence the Officers concerned in their favour by personal canvassing will disqualify the quotations.
- If any license or permit is required, quotations must specify in their quotation and also state the authority to whom application is to be made.\
- 4. The Quotation must be for the project including supplies.
- 5. The prices quoted should be inclusive of all taxes, duties, cessetc which are or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery during the course of execution of the contract.
- 6. Any sum of money due and payable to the successful contractor from Government shall be adjusted against any sum of money due to Government from him under any other contracts.
- 7. The CEO & ED reserves all the rights to reject any or all Quotation without assigning any reason thereof.
- 8. Acceptance of the tender constitutes a concluded contract.

9.Successful bidder must within 10 days after the receipt of acceptance letter of his quotation furnish Rs.10,000 (Rupees ten thousand only) inclusive of EMD amount of

Rs.5000 as Security Deposit and execute an agreement in Stamp Paper of required value as per Kerala Stamp Act at his own cost for the satisfactory fulfillment of the contract

- 10. No cooking will be allowed inside the buildings or campus. The caterer will have to bring cooked food. However, hot case will be allowed for keeping food warm.
- 11. The caterer will have to make own arrangements for serving, cleaning of cutlery and the dining hall before and after serving food.
  - 12. Highest standards of hygiene and cleanliness should be maintained while preparing or serving food.
- 13. Food will be inspected regularly and if found insufficient or of poor quality then appropriate deduction at the discretion of the Chief Executive Officer of the KIED will be made while paying the related bill of the Caterer. The Chief Executive Officer also reserves the right to terminate contract at any time during the valid contract period if food is found of poor quality or short repeatedly three times over a period of two months.
- 14. Rate quoted should be inclusive of GST and the caterer has to issue a Tax Invoice as per rules while submitting bills.
- 15. All payments to the caterer will be made by net banking or RTGS or electronic fund transfer after deducting TDS or other statutory recoveries.

#### 5.2. Other Directions and Conditions

- i). The foods need to be prepared abiding by all hygienic norms and the cooked food shall be stored and served under hygienic conditions. The food shall be served in clean utensils. Further it has to be ensured that only hot and fresh food is served to the trainees.
- ii). Rate should be quoted including GST and all other taxes and charges.
- iii). Payment against Tax Invoices should be made only after delivery of the items on monthly basis.
- iv). The Supply Contract remain valid for 6 months from the date of execution of contract agreement. It can be further extended or renewed for a further period of 6 months on the basis of contract performance appraisal with mutual consent
- v). The Tendering Authority (The Chief Executive Officer and Executive Director, Kerala Institute for Entrepreneurship Development (KIED) ) reserves the right to cancel the work order by giving a notice of 7 days in case of unsatisfactory performance or violation of any of the tender conditions.
- vi). The successful bidder who will be awarded with Work Order (Selection Notice) will have to furnish a Performance Security (Security Deposit) of Rs. 10,000 Rupees ten thousand only) including EMD
- vii). All pages of Technical and Financial Bids should be signed and seal affixed.
- viii). The KIED will provide Dining Hall for serving food to trainees and water for washing and cleaning
- ix). The Contractor or Service Provider will have to procure food articles, vegetables, fish, meat and other essentials of good quality
- x). The Contractor or Service Provider should be in possession of a FSSAI License as per the Foods Safety Standards Regulations

- xi) The Contractor or Service Provider shall make good all damages or loss which may be caused by any act or default of Contractor or Service Provider or his agents / servants / workers to any property of the KIED
- xii).If the space in Technical Bid or Financial Bid format is insufficient for furnishing full details, such details shall be furnished on separate sheets of paper.
- **5.3- Validity of Tender-** This tender shall be valid and firm for a period of 90 days from the date of opening of the Technical Bid or finalization of tender whichever is earlier.
- **5.4- Site Visit-** Before submitting the bid, the intending bidder shall visit the site to familiarize site conditions and scope of supply if so desires.
- **5.5- Adherence-** Tenders not submitted as per the guidelines stated above are liable for rejection. The decision of the KIED in this regard shall be final.
