I. COMPANY/DEPARTMENT PROFILE:

KIED was established as an autonomous body of the Government of Kerala on 9th November 1994 and established in Kochi in 2005. It aimed to promote the spirit and culture of entrepreneurship among the youth of Kerala by giving them orientation in Human Resources Development and training in skill development and leadership. Initially, the institute was centred in Thiruvananthapuram and was later shifted to Seaport Airport Road in Kalamassery, a rapidly flourishing industrial hub in the state, which sandwiches both the ports and is located nearby Gail India Limited, Hindustan Machine Tools, Infopark, and Nest Special Economic Zone for IT. The location is ideal for the institute, on account of a large number of migrant labourers in the region.
